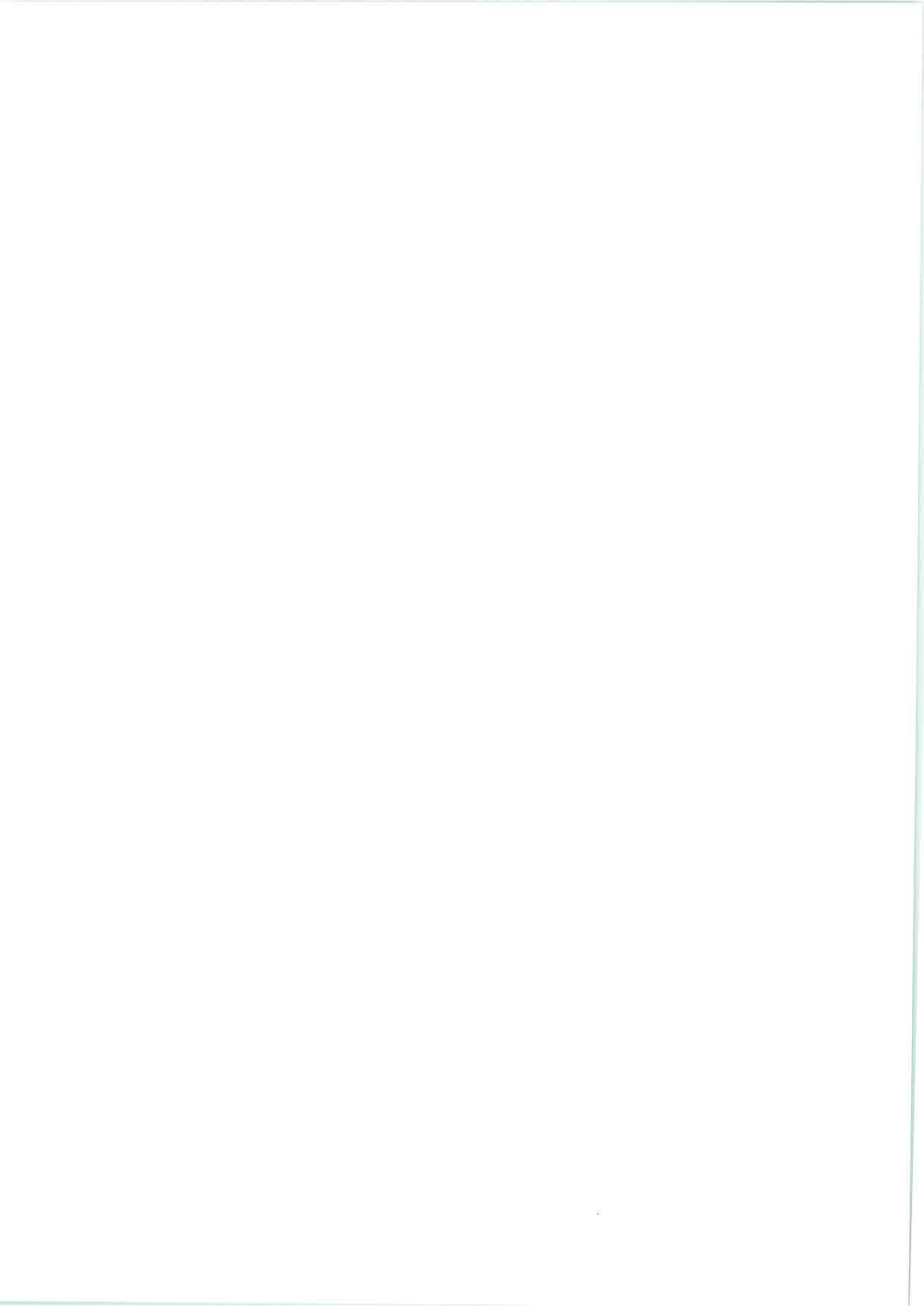

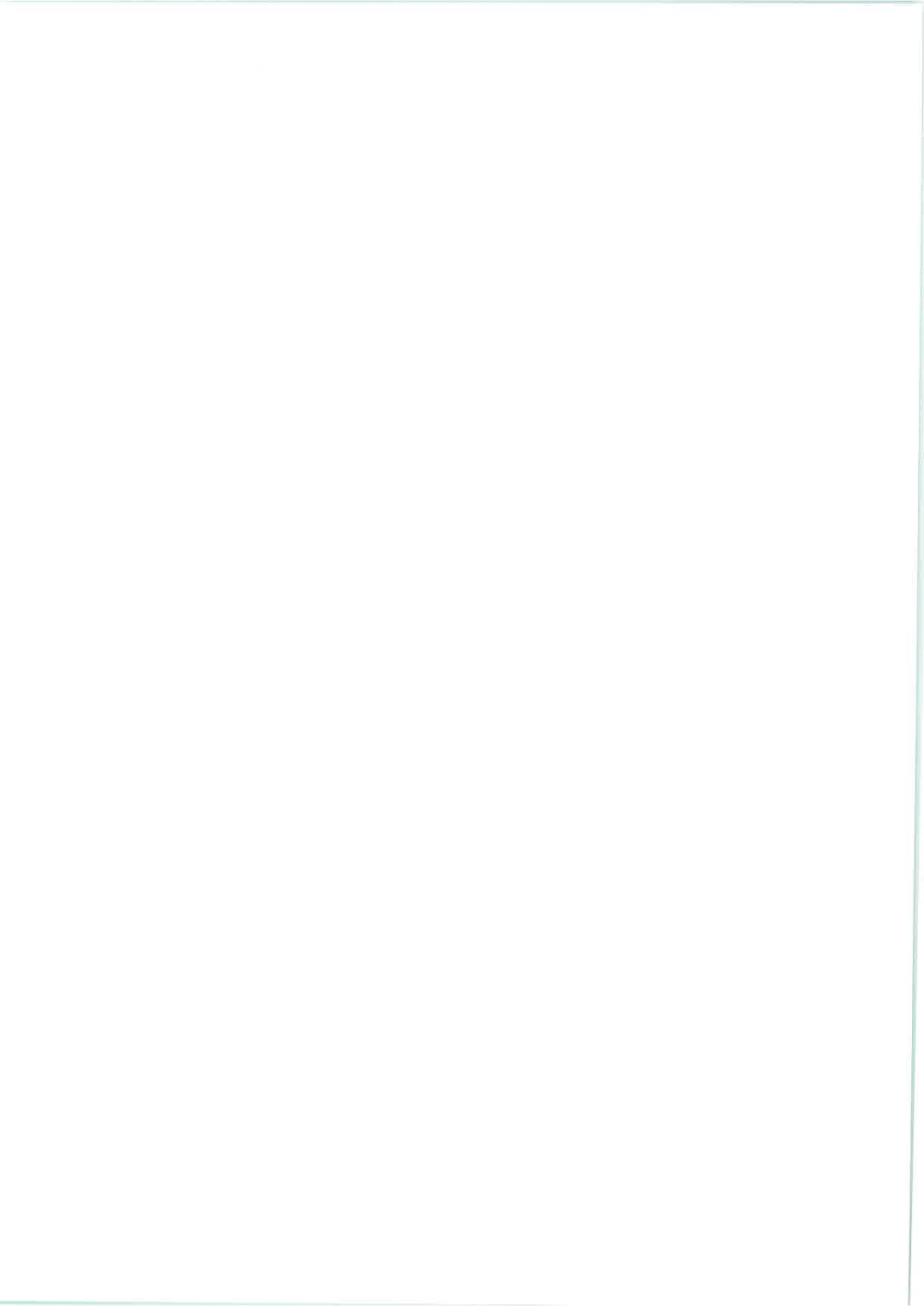

**Subject:** Legal Matter Concerning Unauthorised Event Held on 11th May 2024 – “Pjazza De Box”

Dear Honourable Minister,

I write to you in my capacity as Mayor of the Gharghur Local Council to formally bring to your attention a legal matter of concern currently affecting the Council, arising from an unauthorised event held on the 11th of May 2024, titled “Pjazza De Box”, which was organised under the auspices of the Gharghur Local Council (refer to Document A).

The only recorded communication from the former Mayor, Ms Helen Gauci, regarding this event dates back to February 2024, wherein she informed the Council of her intention to organise a boxing event and secure sponsorships (Document B). No subsequent documentation was presented to the Council concerning budgetary allocations, sponsorship agreements, or logistical planning. Nevertheless, the former Mayor proceeded with confirming event logistics and issued a press release (Document C). It has since come to the Council’s attention—through media reports and direct communication—that one of the event sponsors withdrew, and the logistics provider remains unpaid for services rendered, amounting to €20,200. This figure has been verified through correspondence with the Council’s legal representative (Document D).



The Council has now received a judicial letter under Article 166A of the Code of Organisation and Civil Procedure from the logistics company, indicating their intention to initiate proceedings (Document E). Through its legal counsel the Council has responded through judicial means by refuting the claim. However, in an effort to mitigate further legal exposure and financial liability, I, together with the Council's legal counsel, Dr Joseph Gerada, and the Executive Secretary, held a meeting with the company's representatives and their legal counsel to explore a possible settlement.

During an emergency Council meeting convened on the 11th of August 2025, legal advice was presented and discussed. A vote was taken, resulting in a majority decision (3 in favour, 2 abstentions) to acknowledge the validity of the service rendered and to proceed with the necessary arrangements to see to the payment of the invoices of the logistics provider. However, the Council also resolved that responsibility for the unauthorised commitment should rest with the individual who acted outside the bounds of legal and procedural authority. On the 13th of August 2025, legal counsel for Ms Helen Gauci, Dr Joe Giglio, contacted Dr Gerada to communicate Ms Gauci's willingness to repay the amount of €20,200 in monthly instalments. A request has been made to Ms Gauci's lawyer to provide a formal proposal in writing.

In light of the above, and pursuant to the provisions of **Chapter 363 of the Laws of Malta**, specifically **Articles 55, 61, and 62**, I respectfully request your assistance in allocating a provisional budget to enable the Council to settle the outstanding amount with the logistics provider. This repayment shall be subject to a formal agreement with Ms Gauci, whereby she commits to reimbursing the Council through monthly instalments. The Council shall, in turn, reimburse the Government upon receipt of said payments. Should Ms Gauci default on her repayment obligations, the Council will be compelled to pursue further legal remedies. Your guidance and support in this matter would be greatly appreciated to safeguard the financial and legal integrity of the Għargħur Local Council.
